Child care Fee Schedule

Preschool (only) rates will go into effect on 9-1-2024

Rates are subject to change as they are re-evaluated and updated when necessary. Current rates are posted on the parent bulletin board. A current rate sheet will be sent home as updated.

Extended care is available from 6 AM until 6 PM Monday through Friday. Holidays will be examined and offered by need. Our rates follow publicly funded child care rates. 2 star rated.

Preschool only - 2 days a week (8:00 to 11:00 Tuesday and Thursday) - \$100.00 a month

Preschool only - 3 days a week (8:00 to 11:00 Monday, Wednesday and Friday)
\$150 a month

Payment due the 25th of the preceding month

Preschool age rates for daycare - age 3 years to before kindergarten (all times are rounded to the next quarter hour)

Hourly \$5.50 (1 to 6.75 hours) minimum 1 hour

Part time \$100.00 a week (7 to 24.75 hours)

Full time \$150.00 a week (25 to 60 hours)

School Age rates for daycare - age kindergarten and up

Hourly \$5.50 (1 to 6.75 hours) minimum 1 hour

Part time \$70.00 a week (7 to 24.75 hours)

Full time \$130.00 a week (25 to 60 hours)

School Age Summer Care rates – age kindergarten and up

Hourly \$5.50 (1 to 6.75 hours) minimum 1 hour

Part time \$100.00 a week (7 to 24.75 hours)

Full time \$150.00 a week (25 to 60 hours)

Discounts provided for families with 3 or more children enrolled at this center.

Payment for extended care is due on the last day of the week that your child is here. Your schedule will be set with the administrator BEFORE the week begins. You are responsible to pay for the number of days your child is enrolled OR SIGNED UP FOR, whether or not the child is in attendance. In case of absence, payment should be made by the next day your child is at the center, or within one week, whichever comes first. This policy will be strictly enforced.

If your child is a PFCC student, you agree to pay your co-pay on Friday of the week your child is in attendance. If this payment is not received by MONDAY of the next week, your child may not attend child care until the co-pay has been paid.

*Three free days will be given per summer for part time families for family vacations. *Five free days will be given per summer for full time families for family vacations. Two week's notice will be required in writing and given to the administrator. Subsidized children who sign up for a day of daycare and then do not show up or cancel will be charged the subsidized fee that would have been normally paid to the center if their absence days have been used. Thank you for your consideration in this matter.

Other Fees

Registration Fee - \$50.00 per child. If a child is withdrawn more than 30 days, a new registration fee will be charged.

Supply Fee - \$40.00 per year per child (preschool students only)

Late Pick-up Fee - \$1.00 per minute past 6:00 P.M. \$10.00 minimum charge. This policy will be strictly enforced.

Late Payment Fee - \$10.00 per week.

Summer Activity Fee – (school agers only) - \$50.00 per child – this covers pool fees, pizza, ice cream, guests, etc.

Returned Check Fee - \$30.00 - after two checks have been returned by the bank, only money orders or cash will be accepted.

Collection Fees – In the event that Ann's Bright Beginnings Preschool, Ltd. must retain a collection agency or law firm to collect past due balances owed to us, you agree to pay any and all collection agency fees, court costs, attorney fees or incidental costs associated with collecting. *All fees are non-refundable.*
